

## Florida High Wind Roof Tile Self-Adhered Underlayment Requirements as of 2/29/2012

### This technical brief serves as an addendum to the current FRSA/TRI Concrete and Clay Tile Installation Manual, 4<sup>th</sup> Edition

The FRSA/TRI relied solely on information provided by each manufacturer and has not performed any testing to substantiate this list or findings therein. Please refer directly to manufacturer's product approval, specifications, testing, and any other information. The implementation of the FRSA/TRI 5<sup>th</sup> Edition Installation Manual has been delayed in an effort to properly coincide with the 2013 Florida Building Code (FBC). The FRSA and TRI have been working together on the revised manual to help improve the performance of tile roofs and simplifying the structure of the manual. The primary product related change is a recommendation that all self-adhered cap sheet products meet specific test standards established by the committee. Manufacturers that complied provided written verification that their products would meet or exceed the new FRSA/TRI roof tile manual and criteria for inclusion on the following list of "approved underlayments." *This is not an endorsement by the FRSA and TRI for any specific underlayment, but is compiled upon the technical information provided by the manufacturers. The FRSA/TRI is not liable for the accuracy of the list. For complete information, please contact the actual underlayment manufacturer directly.*
