EXCEPTION NEEDED FOR STEEP-SLOPE ROOFS



When OSHA published a Request for Information (RFI) on Table 1 engineering controls in the silica standard for construction, the Construction Industry Safety Coalition (CISC) met to develop a response. TRI Alliance and the National Roofing Contractors Association explained that Table 1 will not work for steep-slope tile roofing because of the fall-protection issues of water on roofs and the potential for dropping heavy saws from the roof. TRI Alliance responded to OSHA's RFI by stating that fall protection for steep-slope workers should always be the top safety priority, and OSHA should have an infeasibility exception for steep-slope tile roofing in the silica standard that allows for fall hazards.

INDUSTRY RESPONSE: HEAT EXPOSURE BILL

A House committee recently held a hearing on HR 3668, which requires OSHA to issue a standard to protect workers from heat-related injuries and illnesses. The Construction Industry Safety Coalition (CISC) sent a letter to the committee highlighting major concerns, including:

- HR 3668 doesn't account for complex issues associated with heat exposure.
- Determining "excessive heat" depends upon individual risk factors.
- The bill requires OSHA to establish a standard that is no less protective than the most protective state, which would be virtually impossible to implement.

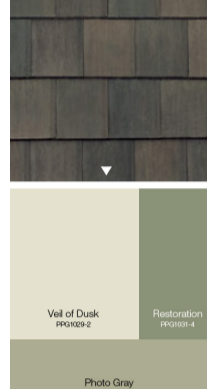
TRI Alliance signed this letter of concern.

GOVERNMENT AND LEGAL NEWS

TRI ALLIANCE GOVERNMENT RELATIONS COMMITTEE & OTHERS

One of the first legislative issues TRI Alliance took on was changing the Residential Energy-Efficiency Tax Credit (IRC Sec. 25C) to cover all roofing products meeting Energy Star requirements. We succeeded when 25C and other tax incentives that are typically renewed each year (tax extenders) were renewed through the end of 2016. The Tax Cuts and Jobs Act of 2017 eliminated a number of tax extenders, but in 2018 Congress retroactively renewed others, including 25C, through 2017. With no congressional action since then, 25C expired on December 31, 2017. On June 20, legislation was approved that extends many tax extenders through 2020.

PROTECTING THE RIGHT TO ORGANIZE

The Protecting the Right to Organize (PRO) Act (HR 2474) would allow personal information to be shared with unions without employee consent; eliminate the right to a secret ballot for union elections; change independent contractor criteria; mandate third-party arbitration for collective bargaining; and other related activities with wide-ranging implications. The House was expected to vote on the bill in mid-November at the earliest, and with 216 co-sponsors it will likely pass.

EEOC DEVELOPMENTS

Businesses that are required to file EEOC's EEO-1 form must provide the number of employees who work for the business by job category, race, ethnicity and sex (data now referred to as Component 1). EEO-1 was revised to add Component 2 data, which includes hours worked and pay information from employees' W-2 forms by race, ethnicity and sex. The Department of Justice has filed an appeal, but businesses will still need to provide Component 2 data for now.

WIND CODES UPDATE

The new ASCE-7-16 wind codes broaden the roof zones required for both hip and gable configurations. As the new codes move toward adoption next year, TRI Alliance is developing engineering analysis and updating codecompliant fastening tables to be inserted in our FRSA/TRI 6th edition and the main TRI installation guides currently under review. The ASCE-7 wind code committee is drafting updates for the 2021 code cycle in order to reduce some of the increases found in ASCE-7-16 and support our tile products moving forward.
